Pre-Company vs. Company

We offer 3 levels of competition teams. These teams are designed to give more options and greater opportunities to our dancers, regardless of level. Here are some basic guidelines per team:

Performance Team:

- To participate, simply register with Fall classes (No audition required)
- Must take corresponding Dance Combo class(es)
- Will participate in 1 competition routine, in addition to any Recital classes
- Will attend 1 Regional (Kansas City) competition; no required conventions or workshops
- Will purchase a costume as well as Performance Team warm-up jacket

Pre-Company:

- Will take approx. 3 hours of classes per week (see www.320dance.com for pricing)
- Will participate in 2-3 competition group routines, in addition to any Recital classes
- Will have the opportunity to participate in solos, duos & trios (must meet specific criteria)
- Will attend 2 Regional (Kansas City) competitions (No Nationals or out-of-state travel)
- Will purchase a costume for each routine as well as a Pre-Company warm-up

Company:

- Will take approx. 6-8 hours of classes per week (see www.320dance.com for pricing)
- Will participate in a minimum of 4 competition group routines
- Will have the opportunity to participate in solos, duos & trios (must meet specific criteria)
- Will attend 1 convention and multiple in-studio workshops
- May be eligible to work with guest choreographers for groups and solos
- Will attend 3-4 regional competitions (Out-of-state travel required for Nationals)
- Will purchase a costume for each routine as well as a Company warm-up

I understand that the Studio 320 staff will guide me toward the best team for my current skill level. I understand that simply auditioning or marking my desired team does not guarantee me a place. _____(initial)

I understand that my dancer may not participate in auditions if I have an outstanding balance with Studio 320. _____(initial)

I understand that to participate on a Studio 320 competition team, I must meet all time and financial obligations during the season. If these obligations are not met, I understand that my dancer may be pulled from the program and/or competitions. _____(initial)

I understand that auditions are closed and confidential and that parents/guests are not permitted in the building during this time. _____(initial)

I understand that audition placements take time and are carefully organized to create the most successful teams and individuals possible. I understand that teacher decisions are final and that parents must refrain from contacting the studio or director until 24 hours AFTER results have been posted. _____(initial)
